Respected Sir,

With Due respect I, Arindam Saha, Son of Pradip Saha, resident of Matigara, Khaprail, P.O. & P.S Matigara, Dist- Darjeeling, PIN-734010. Would I like to inform you that yesterday on 02/01/2026 at about 1:00 p.m to 1:20 p.m after visited my customer house at Siliguri I was meet with my father at Siliguri Junction area, near petrol pump. That time one Sandip Malakar with his two brothers and 10 to 15 another goons suddenly came to me and grap my jacket collar from back side and started to beaten up me with helmet, slung me with filthy languages, 3(three) numbers of helmet they were crushed in my head when I became senseless they pushed me into the road and continuously hit me by knuckle, iron rod, kick, buffet in my face, chest, belly, private part of my body, for that bleeding was started from my nose and a gold chain(09 gram approx) snatched from my neck. That time my father and my colleague tried to save me they also slung them and brutally beaten them. Meanwhile one of the culprits said that "Chaku ta Maar, mere fel sala ta k. Junction er pechone niye chol" and forcibly dragged me, I hold down the lower part of a bike they continuously kicked on my hand, grip my neck my to killed me and threatened me to kill me and family. When they tried to attacked me with sharp knife somehow I run away from the culprits and take shelter inside of the office of the Junction Traffic Guard Office after arrived of the traffic police officers all the culprits run away from that place. Thereafter with the help of others me, my father and my colleague went to Siliguri District Hospital and treatment ourselves. Doctor suggest me to better treatment. Yesterday I was not able to go to nearest Police Station. So today I inform you about the incident.

It's also mention that said few months ago Sandip Malakar with some others goons at mid night came at my house and troubled when my wife said them to called

police then they threatened us to kill anyhow and run away. Yesterday they did it but fortunately I survived from them.

But presently I am so much worried about my and my family's life. Previously the culprits threatened me to kill. Kindly look into the matter and take necessary legal action against the culprits as soon as possible.
