Sir,

I, PRANGOPAL BHOWMICK, son of Sri. Swapan Bhowmick, permanent resident of Vill. Kawakhali Near Desh Premik Club, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling, would like to inform you that as follows:-

1. That RINKI DAS (BHOWMICK) aged about 24 years, daughter Late Sunil Das, wife of Sri. Prangopal Bhowmick, is my legally married wife. A Hindu marriage was solemnized between me and my above named wife six (6) years ago as per Hindu rites and customs after performing all marriage ceremonies. Out of our wed lock relation two male children took birth namely PRABIN BHOWMICK (aged about 5 years) and PRADIPTO BHOWMICK (aged about 2 years). We all reside at out above mentioned residential address peacefully and happily.
2. That on 29.12.2025 at about 2.00 P.M. while I was in my above mentioned residence my said wife told me that she wants to go Siliguri Bidhan Market for shopping and thereafter left for Siliguri but did not come back. I later contacted her through mobile phone but it was switched off. I contacted all my relative, friends through mobile phone and asked about her whereabouts but no fruitful result. I also visited known places but did not find her. On 30.12.2025 I had lodged one Missing diary regarding my wife before the O.C., N.B.M.C. & H. Police Outpost, under Matigara P.S.
3. That on 02.01.2026 at about 8.00 A.M. my wife called me through one unknown phone number (Ph. No. 7001076446) and by crying told me that she had been Kidnapped. Suddenly one BIJOY ADHIKARY @ SAMIRAN DUTTA, son of "unknown", called me in my mobile phone and told me that my wife has been kidnapped by him threatened me not to try to trace him or try to inform police than I shall face grave consequences. Said BIJOY ADHIKARY @ SAMIRAN DUTTA told me that he will again call and disconnect the call. I again repeatedly called in that phone number but it is switched off till today.

I therefore, request you to kindly take necessary legal steps against BIJOY ADHIKARY @ SAMIRAN DUTTA and kindly rescue my wife as soon as possible. I shall be ever obliged to you.
