Subject: "Complaint regarding theft of motorcycles from my premises"

Respected Sir/Madam,

I, **Vikash Kumar Sharma**, S/o Jagdish Prasad Sharma, Resident of Agrasen Road, Ward No. 9, Khalpara, Siliguri, West Bengal, L jurisdiction of your police station, do hereby most respectfully state as follows:

That on **25th December 2025**, at about **2:30 A.M.**, my and my sister-in-law's motorcycles were stolen from inside my house premises situated in the lane. The said motorcycles were properly parked inside my house during the night hours. In the early morning, I noticed that my and my sister in law's motorcycle was missing. It appears that some unknown person(s) entered my house during the night and committed the theft of my motorcycle without my knowledge or consent. No one in my family witnessed the incident and the offender(s) could not be identified. The said time of theft was confirmed from the CCTV camera installed in my neighbour's house premises, which shows that the theft took place at around 2:30 A.M approximately.

That one of the stolen motorcycle bears **Registration No. WB 74 AL-7649** & is Black & Red in Colour. The vehicle is a Hero Motocorp Glamour (New Disc variant), petrol-driven, having an engine capacity of 125 cc and

manufactured in the year 2016. The date of registration is 14.
and the body type of the vehicle is motorcycle.

That the engine number of the said motorcycle is JA06EJGGE2,
the chassis number is MBLJA06ANGGE0852. There is no hypothecation,
hire purchase or lease against the said vehicle.

That the other stolen motorcycle bears Registration No. WB74AR5525 &
is

Red in Colour. The vehicle is a Hero Motocorp Glamour FI / Disc Cast
(Self FI BSVI), petrol-driven, having an engine capacity of 125 C,
manufactured in the year 2017. The body type of the vehicle is
motorcycle and the RTO location is Siliguri, West Bengal.

That the engine number of the said motorcycle is JA06EHH9D01236
and the chassis number is MBLJAS020H9D00243.

That immediately after discovering the theft, I searched the nearby
locality and made enquiries with neighbours, but the motorcycle
not be traced. The theft of my vehicle has caused me serious
inconvenience, mental distress, and financial loss.

I would also like to bring to your notice that I had Dialed '100' and
informed regarding all such to the police and gave them every
information regarding the same , and the time of such call was of 8-8:30
am as on the 25th of Dec 2025, in continuance to which the polic.

and investigated the said matter and then I, Vikash Sharma le.
same day for some urgent work out of Siliguri,

I am lodging this complaint to bring the matter to the notice of the
authorities and humbly request your kind office to enter the same in the
General Diary and/or register an FIR, initiate investigation, trace and
recover my stolen motorcycle, and take necessary action against the
unknown offender(s).

I shall extend full cooperation to the police and provide any
information as and when required.
