Sir,

With due respect I am producing herewith arrested accused person namely 1) Namita Das (30) D/O Prituwish Das of Shivmandir Medical more PS Matigara, Dist Darjeeling 2) Sonia Roy (19) D/O Rajesh Roy of Gossainpur PS Bagdogra, Dist Darjeeling 3) Sathi Roy (23) D/O Anu Roy of Medical, Thiknikata PS Matigara, Dist Darjeeling 4) Tamalika Barman (19) D/O Shibben Barman of Medical more, Nimtala PS Matigara, Dist Darjeeling 5) Sanghamitra Roy (22) D/O Amir Ch. I SI Chabilal Singha presently attached with NJP PS, Siliguri Police Commissionerate under your kind control beg to state that today on 03/01/2026 I was detailed as QRT duty under New Jalpaiguri PS jurisdiction. On around 12.45 Hrs as per the information of duty officer, I along with SI Samik Paul, SI Tanmoy Kundu, ASI Bhai Chandra Tamang along with C/318 Anjan Kumar Mahato, C/1462 Sajan Tamang, VP/13 Jamirul Islam, VP/08 Laxman Roy accompanied with van officer SI Sunil Gurung and ASI Bhai Chandra Tamang and force went to Shaktigarh Balika Vidhyapith. Being there it came to learnt that some persons have assembled unlawfully nearby Shaktigarh Balika Vidhyapith and blockage the road along with minor students of Shaktigarh Balika Vidhyapith without proper permission which causes public obstruction, danger and nuisance which may leads the law-and-order situation. Further I came to learnt that the above noted persons manipulate the minor students and let them stand against their teachers for charging the higher admission fees. The above noted persons also restrain the school staffs and teachers within the school premises from proceeding beyond school premises and threatened the school staffs with dire consequences. Then police make announcement regarding the gathering to be unlawful and asked to disperse for the well-being of the minor students who were in the school uniform but on which the gathering became agitated and violent. They started threatening the Police and the assembly did not pay any heed to the announcement. The Police chased them to disperse with making all arrangements for safeguarding the students in uniform, on which they obstruct the police personnel to discharge their Govt. duties. Further they sat on the streets and on the process of dispersing some of the agitators assaulted the police personnel and received injuries. To avoid commission of further cognizable offence the above noted persons were arrested on preventive grounds.

Hence, I pray to you considering the offence the specific case may kindly be started against the arrested accused persons under proper section of law and arrange for its investigation.
