With reference to the above captioned subject matter We are deeply aggrieved to inform that I Ujjwal Agarwal Son of Kishan Agarwal , is bonafide owner of land measuring 30 decimal in LR Plot No 202 in RS 150 recorded in My name in Land Record of Govt of WestBengal Ref LR khatiyani No 1129 vide deed of registration No 3561 and No 6293 of the year 2023 (**Collectively Marked as Annexure "A"**), where a **Status-Quo order** has already been passed vide **TS No 326/2025** by Honble Ld Civil Judge Junior Division at Jalpaiguri Dated 24-12-2026 (**Marked as Annexure "B"**)

Furthermore My family member Namely Shri Vishal Agarwal and Smt Charu Agrwal are another Co-owner of the LR Plot 202 Corresponding to Rs Plot No 150 measuring 54 Decimal along with some other plot their total area being 356 Decimal vide Revised Lr Khatiyani No 414 and 415 reference earlier LR Khatiyani No 393 & 395 Purchased vide deed No 3933.3934 and 3935 of the year **2011 (Collectively Marked as Annexure "C")** Moreover there is still a Order of Permanent injunction passed by the Honble Court of Civil Judge Junior Division ,Jalpaiguri Passed Dated 8-11-2019 **Ref TS No 340 of 2019** and which is still subsisting as on Date Marked as Annexure (**Annexure "D"**).

Now on the night of 27-12-2025 one of the Camera was broken by the local goons one of them being Rafiq Hussain S/o Ajibaddin Md ,resident of Sitaguri having Mobile No 8293139209 the same person against whom and other associate the Honble Court OF Civil Judge Junior Division at Jalpaiguri was pleased to pass an order of **Status Quo Marked same as above Annexure "B"**

More surprisingly on morning of 28th December 2025 We found the same Goon Rafiq Hussain along with other antisocial elements another one of them being Sanarul Haque alias Bhochook and his Son Sarul Hoque are trying to encroach and grab our piece of land in aforementioned LR Plot 202 corresponding to RS Plot 150 and are excavating the land and trying to illegally encroach and grab the aforementioned piece of land in LR plot 202 , We being the bonafide purchaser of entire area of LR plot of land 202 and the aforesaid goons are finding various means to grab Our land which is well demarcated and in Our physical possession ..On confronting afore mentioned Goon Rafiq Hussain gave threatening of dire consequences to Me ,My Uncle Vishal Agarwal ,Aunty Smt Charu Agarwal and Security Guard along
