This is to inform you that I own a flat at Rose
Residency, Salgaon (opposite of Kanchakra Monastery),
Flat No. E1. My name is Bhuvan Chik Banik, Do Kapi Chik Banik.

Yesterday at 17:54 hrs, I received a call from Bijay
Jha, Manager of Rose Residency that the lock of my Flat has
been broken and door left open. I am presently residing at
my place of posting at Algaon, Kalimpong. I immediately
started off for Siliguri and reached Salgaon at 20:40 hrs
on 04/01/2026.

Upon reaching, I found the grill broken and flat door
damaged. All Almirahs were found to be open and drawer
lock broken of the Almirah at my bedroom. An amount
of Rs. 1 lakh is found to be missing from the drawer.
The house was in a messy condition. There was a small
silver coin too which is also missing.

Other flat owners like K.T. Bhatia, Deepak Gungy
~~was~~ also present during the time I entered the flat along
with Bijay Jha, the manager of Rose Residency. I had
last visited my flat on 25/12/2025 and left for Algaon in
the morning on 26/12/2025.

Under the above circumstances, I request you to treat
my complaint as FIR and take necessary action accordingly.
