Subject-Regarding Unauthorized trespassing of possessed property under physical possession by the order of Learned ACJM Siliguri being Misc case order no-121 of 2025 dated 28.08.2025 of ICICI HFC

Sir,

This is to bring into immediate attention that Borrower, Co-Borrower with the help of other's (local brokers) has broken the lock of property that we had possessed with the help of Siliguri police commissionerate, Bhaktinagar Police station and Learned ACJM Siliguri. In detail view, on 08-10-2025, we had taken physical possession and sealed the mentioned property and inventory inside through Court order with the help of Appointed court commissioner, Reserved police of Siliguri commissionerate and Bhaktinagar police station.
