- ③ Gold tikli weighs 3 grams.
- ④ Silver Anklet of 10 grams.
- ⑤ Donation Box (Cash approx 10-15 thousand) of Swapneswari Bolla Kali mandir.
- ⑥ Donation Box (Cash approx 15-20 thousand) of gupteshwar dham Shiv mandir.
