
Sir

This is to inform you that on 09.01.2025, one person, namely Shri Raj Kumar Agarwal, submitted a letter to the Siliguri Municipal Corporation praying for refund of double tax payment amounting to Rs. 18,855/- (Rupees Eighteen Thousand Eight Hundred Fifty-Five only) in respect of Holding No. 48/32/623/1. The said person also enclosed two money receipt vouchers: (i) Receipt No. 7408 dated 30.12.2022 for Rs. 18,755/-, and (ii) Receipt No. 8080 dated 18.01.2023 for Rs. 18,855/-.
