Respected Sir,

I, Sri Jasilin Chakraborty, Daughter of Jasbin Lepcha, resident of Salbari, Nayabasti, Post Office - Methibari, within the Pradhan Nagar Police Station, District - Darjeeling do hereby lodge this FIR on the following effects with the request for taking immediate action and arrest the culprit immediately.

1. That I am tribal lady and since more than 30 years I along with my family are resident in the land situated in the address mentioned above by constructing a house.
2. That nearly three years back one Simon Lepcha, son of late Parthuk Tshering Lepcha besides my back encroaching into my land by way of fraud and forgery as well as by suppressing the fact that he was an employee of State Government has managed to obtain a Patta being Patta Case No. 38/XII/07 and constructed an unauthorized house.
3. That during these 3 years after several letters made to different authorities and several cases instituted to different Court including the Hon'ble High Court, in compliance the Order of WPA No. 1540/2023 dated 28.08.2023, Pradhan, Champasari Gram Panchayat, with the concurrence of S.D.O, Siliguri and after verifying with the Executive Officer, Panchayat Samity were the Executive Officer made no such permission of building plan has directed the Simon Lepcha for dismantling the said unauthorized house moreso S.D.O Siliguri vide Order dated .24.11.25... annulled the Patta of Simon Lepcha, son of Late Parthuk Tshering Lepcha.

It is also need to state that Simon Lepcha on different times lodged false complaint to grab my land and also made conspiracy to prepare false report with BLLRO, Matigara and on understanding the illegal motive of the Simon Lepcha, Commissioner of Police not accepted the report submitted before the Ld. Special Executive Magistrate Court in the Petition case No. 50/2023 and ultimately the Commissioner of Police dismissed the Petition filed by the Simon Lepcha.
5. It is very painful to state that few days ago, the Simon Lepcha with ill motive had made attempt to outrage my modesty and also of my mother, and over the issue one written complaint were lodged and later on, on the basis of the apology the said written complaint was kept in abeyance. After the above incident in order for the safety and security of myself, my mother and for my father I installed CC CAMERA in my house.
6. That today at about 4:00 AM Simon Lepcha suddenly with his association along with his family members namely Sharmila Chettri, wife of Simon Lepcha, Gaynon Lepcha, Son of Simon Lepcha, Yashoda Pradhan, Wife of James Lepcha, Noila Lepcha, Daughter of James Lepcha, Ali Lepcha, wife of Passang Bhutia, Arpan Lepcha, son of Augustin Lepcha entered into my house with weapons like iron rod, lathi, Kurpi, and dashed me, modest my mother, assault my father and personally assault me with ill motive and unlawfull nammer touch my body while resisting threatened my family, I got injured and went to hospital for treatment which is not only unwarranted but unprecedented too, his motive and unlawful action seeks very dangerous & notorious in nature for my family and hence he and his all family members mentioned above committed the offence as provided in BNSS and therefore I pray before you to arrest the Simon Lepcha and all his family members and provide justice to and to my family.
