Sir,

It is to inform you that I, **Debraj Das**, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against **KANTI DEVI, W/O- VIJAY PRASAD**, Address-Debidanga Bazaar, opp: Ganesh Mandir Road, P.S Pradhannagar, Dist-Darjeeling, Pin-734003 for **using a domestic meter for commercial purpose (running a grocery store) and providing power to a deemed disconnected premises.**

Today i.e, on **07.01.2026**(13.03 hrs), I came to Debidanga Bazaar, opp: Ganesh Mandir Road, P.S Pradhannagar, Dist-Darjeeling; in my officially hired vehicle for a routine inspection. I was accompanied by (i) Bijay Lakra, SE(S&LP), Darjeeling Region, (ii) Bhaben Roy, SO(S&LP), Darjeeling Region, (iii) Rabi Sankar Singh, SrOE, Pradhannagar CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises (after observing all formalities), I found that the meter **GE0974841** (Consumer Name- **KANTI DEVI, Domestic Rural Category, Con Id-403216421**) is being used for COMMERCIAL purpose (Kanti Enterprise). The premises already has a DEEMED disconnected meter **T2333261** in the name of **Vivek Kr Prasad** (Con Id-**401835453**) having OSD-Rs.**12415.83**, LPSC-Rs.**2291.21** as on 07.01.2026.

I disconnected the connection of **KANTI DEVI** & seized the meter **GE0974841**, after preparing the seizure list duly signed by the witnesses. Local people were present but none appeared.

Seized Articles:

- 1 phase energy meter **GE0974841**, 240V, 5-30A, 3200imp/unit Make- Genus (L/R-1135 KWH)

Ashutosh Prasad, son of Kanti Devi, was present at the premises & received the Notice, Inspection Sheet & Seizure list.

As such, **KANTI DEVI**, has used a domestic meter for commercial purposes illegally and un-authorizedly and providing power in a deemed disconnected premises having outstanding dues and is liable for prosecution U/S **135 1(e)** of Electricity Act 2003. Hence, you are requested to treat this as FIR.
