Sir,

It is to inform you that I, **Debraj Das**, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against **AKASH LAMA**, Address- Mahishmari, near Sunrise School, P.S Pradhannagar, Dist-Darjeeling, Pin-734003 for **using a domestic meter for commercial purpose (running a commercial establishment)**.

Today i.e, on **07.01.2026** (12.18 hrs), I came to Mahishmari, near Sunrise School, P.S Pradhannagar, Dist-Darjeeling; in my officially hired vehicle for a routine inspection. I was accompanied by (i) Bijay Lakra, SE(S&LP), Darjeeling Region, (ii) Bhaben Roy, SO(S&LP), Darjeeling Region, (iii) Rabi Sankar Singh, SrOE, Pradhannagar CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises (after observing all formalities), I found that the meter **B2385706** (Consumer Name- **AKASH LAMA**, Domestic Rural Category, Con Id-402320651) is being used for COMMERCIAL establishment (OHO HOMES).

I disconnected the connection of **AKASH LAMA** & seized the meter **B2385706**, after preparing the seizure list duly signed by the witnesses. Local people were present but none appeared.

Seized Articles:

- 1 phase energy meter **B2385706**, 240V, 5-30A, 3200imp/unit Make- Bentec (L/R-6767 KWH)

Chandra Prakash, representative of Akash Lama, was present at the premises & received the Notice, Inspection Sheet & Seizure list.

As such, **AKASH LAMA**, has used a domestic meter for commercial purposes illegally and un-authorizedly and is liable for prosecution U/S **135 1(e)** of Electricity Act 2003. Hence, you are requested to treat this as FIR.
