Sir, I request you kindly lodge FIR against Mr. Deepak Kumar Paswan and Mrs. Rupa Paswan and recover my given money.

Sir, I am getting Mentally tortured, Economically tortured, Physically tortured by the ongoing situation and living, disturbing life due to money cheated by Mr. Deepak Kumar Paswan and Mrs. Rupa Paswan.

Sir, Deepak Kumar Paswan and Mrs. Rupa Paswan Running the DD in his Shop. I am also submitting the bank account statement with affidavit of the bank account statement. Kindly look after this case.
