 I Smt. Sumanwati Das, the above noted complainant try to inform you that, on 07.01.2026 at about 07:30 pm, when my husband namely Shankar Das (40) s/o Lt. Gobind Das, was trying to save his friend namely, Lakhendar s/o Lt. Satchar Saha of Near Kacha Manth, Hemanta Busu colony, at New Shree Shakti Mandir, Hemanta Busu colony, Ward No. 4, P.S. Siliyuri, from the hands of above noted alleged persons, then they all started abusing him in filthy language and when I protested, they started beating him brutally, with fist & blow and they attacked on my sweet husband with Bolgha, my husband Shankar Das, received severe injury on his person and the above noted alleged persons torn off my saree & disrobed me and stolen away my (1) Gold Mala (Tikra with 3 pendant) & (2) Gold ear Rings, mykars my neighbours namely, (1) Santosh Saha (30) s/o Lt. Pratikhan Saha & (2) Dinesh Kantti (20) s/o Sri Narasi, Kantti, both are of Hemanta Busu colony, and w/o (3) Sri Babu Saha (20) s/o Sri Santosh Saha (4) Sonu Kantti (20) w/o Sri Ranjit Burman & (5) Chanda Saha (30) w/o Sri Sunu Kantti, all are of Hemanta Busu colony, tried to save my sweet husband from the above noted alleged persons, also attacked on (1) Santosh Saha & (2) ~~Pradman~~ Dinesh Kantti, later about and injured from severely.

My husband namely (1) Shankar Das & my neighbours namely (2) Santosh Saha & (3) ~~Santosh Saha~~ Dinesh Kantti, noted above immediately shifted to Siliyuri Distt. Hospital & treated themselves there.  
 Sir, the above noted alleged persons are of very desperate & dangerous in nature & they have threatened us for dire consequences. So, please take necessary action against them.
