Respected Sir/ Madam,

I, Smt.Kiran Das, W/o Sri Sanjay Das, residing at Hemanta Basu Colony, Near Shiv Shakti Mandir, Ward No. 04, P.S. Siliguri, Dist. Darjeeling would like to inform that today i.e. on 7/1/2026 at about 09.00 p.m. when I along with my mother namely Bhagwan Das, W/o Sri Ramjapo Das, and also one neighbor namely Rita Das Standing in front of my house at that time one person of our locality namely **Lakhindar Sha**, S/o not known, C/o MD. Aslam, R/o. above-noted address (same locality) came in front of us and used some slang languages in respect of our community and it is also important to mention here that last few days he always came in front of our house and used slang language in respect of our community for that reason when today at about 09.00 P.M. he used such type of languages in respect of our community at that time no other alternative I along with my above named mother as well as above named neighbor protested the same and due to said reason the above noted person become ferocious and started to use slang languages in respect of me and also in respect of the above noted two female members when me and above noted two female members protested the same at that time he become ferocious and out of ferociousness he called another three persons namely **1. Sri Shankar Das, S/o Lt. Gobind das, 2. Akash Das, S/o Sri Shankar Das, 3. Smt. Sonabati Das, W/o Shankar Das**, all of them are resident of above noted address (same locality) and after that all of them started to assault me and my above named mother with the help of **lathi and bamboo** with a clear intention to kill us and after listening our hue and cry when my maternal brother namely Gourav Das try to rescued us from their hands at that time they also assaulted my above named maternal brother with fist and blows and due to assaulted by them me and my mother sustained multiple injuries on our whole body and due to said assaulted by them me and my mother feel very unhealthy and due to said reason the local person interfere into the matter and rescued us from their hands and took me and my mother Siiliguri Sadar Hospital for treatment and we were treated there as an indoor patient and it is also pertinent to mention here that at the time of said incident the aforesaid male persons intentionally touch our private parts of body and disrobe me and my mother in presence of local people and at the time of left the spot they threatened us with dire consequences and told us that if me or my any family members lodge any complaint against them before any authority then they will come again and kill us So, right now me and my family members spend our every minutes within fear So, no other alternative way today with the help of my well wishers or friends I knocked your door and lodged this complaint before you against the above named persons
