Respected Sir,

With due respect, I, Gourav Agarwal, Son of Santosh Kumar Agarwal, resident of Khalpara, Siliguri would like to inform you that a Fraud committed with my Mother, Pushpa Devi Mittal, aged 62 years by three persons in front of Agrasen Chikatsalay, Khalpara, Siliguri-734005.

The Brief incident of the case are as follows:-

On 27<sup>th</sup> December, 2025, My Mother was going to Mandir around 11:00 AM, When she reached near Agrasen Chikatsalay and was going to take turn towards Agrasen Bhawan a young person, fair complexion approx. 32-35 years approached her and informed her that a Person who pretends to be Officer was standing near Agrasen Chikatsalay and wanted to talk to her. My Mother denied 4-5 times that she will not go but the person forcefully requested my mother to meet the Person who pretends to be Officer. My Mother was in confusion what to do and unwillingly went to the Person who pretends to be Officer. The Person who pretends to be Officer aged 45-50 years fair complexion was wearing good clothes and falsely told my mother that a lady named Lila Devi Agarwal had been murdered and her gold ornaments had been snatched so it was not safe for her to wear gold ornaments so please remove her gold ornaments. The Fake Officer also told her that a gang has came and it is not safe for her to wear gold ornaments for 2-3 days and if she wears gold ornaments a fine of Rs. 10000/- will be levied on her. A third person from somewhere came near that Fake Officer and shown his chain which he is wearing to him and gave his chain to him and told my mother to do the same. My Mother being hypnotised gave her Artificial chain and the diamond gold bangles which she was wearing to the Person who pretends to be Officer and the Fake officer in return gave a paper to my mother containing artificial bangles and told her to keep it in her bag. The Person who pretends to be officer has replaced the original diamond gold bangles with artificial bangles.

I therefore request to kindly register an FIR investigate the matter thoroughly, identify the accused persons and take necessary action at the earliest.

I shall be highly obliged for your kind cooperation.
