RESPECTED SIR,

I Supiana Khatun, W/o Md. Mamun, D/O Faruk khan, Resident of Paschim Dhantala, P.O Satellite Township, District Jalpaiguri, would like to inform you that one Md. Mamun Son of- Beauty Begum, Resident of – Mantadari, Belakoba, Police Station- Bhaktinagar, Dist- Jalpaiguri, Pin- 735133, Presently residing at- Paschim Dhantala in the house of her Sister namely Mousumi Begum. The above named person started to follow and stalk me when I was minor, since 2014. That slowly he persuaded me to marry him, and also by undue influence took my birth certificate, stating it is for my own benefit and in the year 2016 when I just turned major, then on 20.04.2016 he took me to the ADSR Office Jalpaiguri and got our marriage registered under Special Marriage act, by influencing me, that he shall take care of me and showing love and affection towards me.

Since that day whenever I requested him to provide me with the Marriage certificate and take me to the matrimonial home he kept on avoiding on various pretexts and stated that as I am still young the family and society would not accept such marriage and promised me to take me after a year. For five years he made false promise of taking me to his matrimonial house on various reasons every now and then. However in the year 2021 he stated that he has submitted the marriage certificate and Birth Certificate in some office and to get it return **Rs.10,000/-** is required. I denied to his illegal demands and stated him to immediately return the said documents and also to take me to the matrimonial home to which he did not pay any heed. However to my utter shock he showed me that he had created my fake **AADHAAR CARD** without my consent or my signature and even without informing me, and threatened me to give him **Rs10,000/-** or else he shall misuse such documents and spread false information about me, also asked to keep my mouth shut and not state anything to one, I got frightened and under such circumstances I was compelled to provide him the above amount. Even then he did not return any documents to me. Again in 2023 he demanded an amount of **Rs.2 lakhs( Rupees Two Lakhs)** from me stating that he is urgent requirement of funds, and when I stated that I am incapable of giving him such amount. He time and again threatened me by calls and by personally stalking me in places where I use to visit on regular basis and tried to extort money from me. After sometime he again stalked me and showed me that he have created a Job card in my name in some company, Ration Card and even Voter Card, all of them without my knowledge or consent and behind my back. I would like to state that these documents are all made by him with the help of his associates and are false. He then threatened me stating that if I do not pay him the amount he shall use such documents for all sorts of illegal acts and deeds. He also threatened me that he got hold of my personal picture and if I do not act as per his whims and fancies he shall spread the picture all over the social media. Under such circumstances I got very much frightened and passed my days under tremendous mental trauma and agony,

finding no other alternative I informed my family members and filed one Matrimonial Suit being no 308/2023 pending in the court of the Ld. Additional District Judge 3<sup>rd</sup> Court at Jalpaiguri. After he received the summons of the case he started to threaten me more over calls and messages and stalking me everywhere, and pressurized me to withdraw the case. I requested him numerous times to delete the said picture but he kept on illegally demanding money from me or else he shall spread the said picture all over the social media and destroy my image in the society. In this manner he has been trying to extort money out of me. In this manner he started to blackmail me and threatened me that if I do not withdraw the case he shall spread the image to more and more persons and all over the social media. Since such date he and his friends and associates used to stalk me and harass me in public whenever he used to find me alone. Since beginning of 2024 he started to also disturb me by following me to court premises on each and every date when I used to appear for the above case. He started to stalk me and threatened me by saying that I shall withdraw the case or he will also spread the images in the court and I won't be able to show my face here. He again on 24/9/2025 when I went to the court premises started to taunt on me, and followed me to my home. Finally on 2.12.2025 when I was going to a nearby store he followed me and threatened me that if I do not pay him **500,000/-Five lacs** within this month (DECEMBER) he will share my number to more unknown persons along with pictures of mine, and even spread over the internet. Whenever I went out of house he stalked me and gave abusive slang languages to me in public places and threatened unless he will receive the money stated above and the case is withdrawn he shall continue to do more such misdeeds and make our life living hell.

Your goodship, the above named person by influencing me when I was a minor married me and never took me to the matrimonial house rather made false documents in my name and used the same for his benefit and extorted money out me and is still trying to extort money out of me and my family members. He have also threatened me and my family members, stalked me and abused me with the filthiest of languages in public places, and threatened me that if I do not provide him with the amount of **Rs.500,000/- Five Lakhs** then he shall make my life and image in the society as a prostitute. I, and my family members under such grievous situation are passing our days under tremendous mental trauma, agony, and fear.

I am also apprehensive that if necessary legal action is not taken against the above named person at the earliest he shall continue with his misdeed and acts. I hereby pray before you to take the necessary action at the earliest and book him as per law.
