Subject: Written complaint against my husband for continuous cruelty (mental & physical), harassment, criminal intimidation and attempt to murder by strangulation.

Sir,

I, Safali Mandal, wife of Gobinda Mandal, daughter-in-law of Late Chandrabhan Mandal, by profession housewife, presently residing at Dakshin Shantinagar, Jabravita, near Polytechnic College, P.S. NJP, District Jalpaiguri, do hereby most respectfully submit this written complaint against my husband Gobinda Mandal, (8972992530) son of Late Chandrabhan Mandal, by profession carpenter, presently residing at the same address, for committing grave offences of cruelty, assault, criminal intimidation and attempt to murder.

That on 04.02.2005, my marriage with the Gobinda Mandal was solemnized through an arranged marriage at my in-laws' house at Gajoldoba, P.S. Bhorer Alo, District Jalpaiguri, as per Hindu rites and customs. After marriage, we started cohabiting as husband and wife and maintained conjugal relations.

That after about six months of marriage, we shifted our residence to Netaji Subhash Road, Bhakti Nagar, near I.O.C. Gate, Siliguri (M. Corp.), District Jalpaiguri, and thereafter we started living at a rented house situated at Dakshin Shantinagar, Jabravita, near Polytechnic College, P.S. NJP, Jalpaiguri, where the accused is presently residing.

That during the course of our matrimonial life, the accused husband started subjecting me to continuous mental cruelty, by commanding me to perform unnecessary and excessive household work, humiliating me, abusing me verbally, and treating me in a dominating and oppressive manner.

That on 31.12.2006, I gave birth to my son Gouranga Mandal, and on 29.12.2011, my daughter Swapna Mandal was born. However, after the birth of my first child, the degree of cruelty increased manifold. The accused started harbouring baseless suspicions regarding my character, alleging illicit relationships with other males, and on regular intervals he assaulted me physically and abused me using filthy and obscene language.

That it is pertinent to mention that the accused is a habitual consumer of alcohol and most of the disputes, assaults and acts of cruelty were committed under the influence of alcohol, particularly during night hours.

That in an attempt to resolve the matrimonial disputes, I approached the Mahila Samiti of Ward No. 35, requesting mediation and intervention. However, no permanent solution was achieved.

That on 18.10.2025, the accused brutally assaulted me, causing serious injuries, due to which I had to be hospitalized and remained under medical treatment for four days. Despite such severe assault, I did not lodge any complaint at that time, keeping in mind the future, education and well-being of my minor children.

That after the said incident, the accused again started assaulting me physically and mentally and continued abusing me in vulgar language.

That on 05.11.2025, the accused forcibly ousted me from the rented house, compelling me to take shelter at my sister's house at Rangiya, Assam. Even there, the accused followed me and abused both me and my sister using filthy language.

That the accused used to assault not only me but also my children, especially at night, under the influence of alcohol. He also stopped providing maintenance to me and my daughter, discontinued my daughter's school and tuition expenses, and shockingly told her to work as a housemaid. He also forcibly ousted my son from the house, locked the doors and abandoned him after consuming alcohol.

That even after complaining to my in-laws, no relief was provided; rather, the accused intensified his acts of violence and cruelty towards me and my children.

That today on 06.01.2026, in the evening hours, when I returned from my sister's house, the accused came in an aggressive and violent manner, threatening to kill me and my minor children, armed with sharp cutting tools used for carpentry. He mercilessly beat my children with wooden sticks. When I tried to restrain him and protect my children, the accused attempted to murder me by strangulating my neck with my dupatta/chonari. Somehow, with great difficulty, we managed to escape and save our lives.

That the accused took away all the cash from the house, went out to consume alcohol, and later returned to lock the main door of the house, forcibly ousting me and my children, thereby leaving us homeless, unsafe and without any financial or physical security.

That at present, neither is the accused providing any maintenance nor are we having any protection or security from him, and there exists a real and imminent threat to our lives.

In view of the facts and circumstances stated above, I humbly request you to Register an FIR against the accused Gobinda Mandal under appropriate provisions of law for cruelty, assault, criminal intimidation and attempt to murder and take strict legal action against the accused in accordance with law.
