Respected Sir,

In producing herewith two arrested accused persons namely Jahangir Alam (Male/30 years), S/O. Sopikul Hoque of vill. Jhagarpar, Par-III, PO. Jhagarpar, PS. +Dist. Dhubri, Assam, 783325 and 2. Md. Murtaza (Male/39 years), S/O. Lt. Ahmed Ali of Chowpukhoria, Halajote, PS. Bagdogra, Dist. Darjeeling along with one Truck bearing Reg. number WB51/C/5088 loaded with 21(Twenty one) numbers of Buffalo (cattle) in different age and size.

I, ASI Aibul Islam of Matigara PS, Siliguri Police Commissionerate beg to report that on 07.01.26 at 01.56 hrs I along with force both of Matigara PS left the PS to perform mobile van duty vide Matigara PS M.C.C. no. 65/26, dated 07.01.26 and G.D.E. No- 368 dated 07.01.26. During my petrol duty on 07.01.26 at 21.05 hrs I received a secret source information that one Truck loaded with cattle which are procured by stolen or fraudulent means is coming from Bagdogra side. Accordingly I informed to I/C, Matigara PS over telephone regarding the information in hand who directed me to verify the veracity of the information. As per his kind order and direction myself along with the above noted force started naka checking on NH31 road at City Centre in order to intercept the said vehicle. At about 21.05 hrs we managed to intercept one Truck displaying number plate WB51/C/5088 at City Centre. On verification, we found two persons sitting inside the driver's cabin. On being asked, they disclosed their name as 1. Jahangir Alam (Male/37 years), S/O. Sopikul Hoque of vill. Jhagarpar, Par-II, PO. Jhagarpar, PS. +Dist. Dhubri, Assam, 783325 and 2. Md. Murtaza (Male/39 YEARS), S/O. Lt. Ahmed Ali of Chowpukhoria, Halajote, PS. Bagdogra, Dist. Darjeeling. During examination, they both confessed that the vehicle is loaded with 21 numbers of cattle. On being challenged, the said two persons failed to produce any valid document/purchase invoice in respect of carrying the cattle. They also failed to produce any permit for carrying live stock in their truck. They also failed to produce any medical checkup certificate in respect of such cattle which is a mandatory provision of law before transportation of any cattle. On further query, they admitted that the cattle were procured by some cattle-smugglers by illegal means from Bihar side in order to supply the same at Assam side.

During physical verification we found that the cattle were loaded in such a manner which caused unnecessary pain and suffering those cattles there are no reasonable space/opportunity for their movement.

I then seized the vehicle bearing Reg. no. WB51/C/5088 loaded with 21(Twenty one) numbers of Buffalo(Cattle) of different age and size after preparing seizure list duly signed by the available witnesses between 21.30 hrs to 21.45 hrs. I then arrested the above noted accused persons for possessing and transporting the cattle which is reasonably believed to be stolen property and for causing unnecessary pain and suffering to the cattle. They also admitted that they had the knowledge that the cattle were stolen one. I intimated both of them about ground of arrest and issued memo of arrest and also observed other legal formalities and brought the above noted arrested accused persons along with seized vehicle no. WB51/C/5088 loaded with 21(twenty one) numbers of cattle at Matigara PS.
