Sub: -FIR for damage to WBSEDCL's LT distribution network by a truck (Reg. No.: UP 78H N2542) at Eastern Bypass near Buraburi Mandir, Fakdaibari on 09.01.2026 around 12:30 am as reported in the night.

Dear Sir,

This is to bring to your kind attention that a truck/vehicle bearing Registration Number: UP 78H N2542 had collided with WBSEDCL's LT Electricity Distribution Network situated at Eastern Bypass near Buraburi MANDIR, Fakdaibari Dist- Jalpaiguri & damaged LT AB Cable that causing financial loss to WBSEDCL. As reported, the incident took place on 09.01.2026 at around 12.30 am in the night. The LT Mobile Van of Subhaspally CCC, immediately after receiving the information, rushed to the spot & did the necessary to avoid any undesirable incident & restored power up to the extent possible.

Around 0.039 Km LT AB Cable has been assessed to be damaged because of the collision, cost of which is assessed of Rs. 19893.94. One copy of Estimate for the damaged LT Cable is attached for your reference.

Hence, your good office is requested to take cognizance of the matter & consider this complain as FIR to take necessary action u/s 139 of the Electricity Act, 2003 (read with amendments) & other relevant laws of the land for the damage caused to WBSEDCL's property.
