On the above - mentioned date and time - I was brutally
attacked by around 10 people main namely Bishal Sahani,
Arash Sahani, Anuj Jha & Md Sahid. I was there
to stop a brawl between teenagers Rids and before I
could realize and grasp the situation I was surrounded
and was beaten mercilessly with bamboo, belt, sticks metal
rod and home utensils. DUE to this incident, I have suffered
serious wound all over my body and I got a concussion
and my head bled heavily the doctor recommended me getting
four stitches and I have a swollen shoulder. and during this mess
I lost my gold chain.

I request you to kindly register a FIR under appropriate
sections of laws. and take necessary legal action against the
accused persons.
