Subject: Complaint against the driver and owner of vehicle No.WB73E9469 for road accident.

Respected Sir,

I, Dilip Jha, S/O Hemkanta Jha, R/O- Kulee Para, Near Kiran Chand Burning Ghat, Ward No.1, P.O. & P.S.- Pradhan Nagar, Siliguri, Dist.-Darjeeling, West Bengal, 734003, do hereby write to you the following for your kind information and necessary action as follows:

1. That on 10.01.2026 at about 12.30 to 1 P.M., my son, namely Udit Jha @ Uditya Jha, aged about 13 years, had met with a road accident near Diesel Loco Shed, Dharam Nagar Road, Ward No.1, P.O. & P.S. Pradhan Nagar, Siliguri-734003. due to the negligence of a dumper driver who was driving the vehicle at the said time, bearing vehicle No. WB73E9469 is loaded with heavy stones.
2. My son was riding his bicycle when he was smashed by the abovementioned Dumper. It is further pertinent to mention here that the dumper was heavily loaded with stones.
3. I received the information from one resident who came to my house and informed me about this accident, which took place at the above-mentioned place of occurrence.
4. I got information that a local person had taken him to Siliguri Civil Hospital. Thereafter, I rushed to Siliguri Civil Hospital, and I saw that my son was lying on a stretcher and the duty doctor declared him dead on arrival.

In light of these circumstances, I respectfully request you to lodge a complaint against the Driver (who is in your custody) and the owner of the above-mentioned vehicle for such a criminal act as per the law of the land.
