Sir,

I, Respectfully submit this written complaint stating that I am pradeep sahani , S/o Shri Rajendra Sahini, of resident of Rajendra Nagar, Cooli Para, Ward No 1 (S.M.C.), P.O & P.S. Pradhan Nagar, Dist Darjeeling. Here by inform you that Today, at about 7 - 7:30 PM, while I was passing near my house situated close to the Railway Line, Rajendra Nagar, Cooli Para, Ward No 1 (S.M.C.), P.O & P.S. Pradhan Nagar, the following persons unlawfully restrained me, abused me, and assaulted me: they are all was drunken condition the persons namely

Gobind Mukhiya, Father's Name – Rajkumar Mukhiya

Kunal Rai, Father's Name – Rajesh Rai

Suraj Rai fathers Name – not known

Prem Kamti, Father's Name – Gunur Kamti

Mahesh Mukhiya, Father's Name – Manoj Mukhiya

Golu Rai Fathers Name – Rontu Rai, all are in the same locality at Railway Line, Rajendra Nagar, Cooli Para, Ward No 1 (S.M.C.), P.O & P.S. Pradhan Nagar

All the above-named persons jointly attacked me, used filthy and abusive language, and assaulted me with hands by fist and blows physical force, causing injuries to my body. During the incident, my mother Sumitra Devi came to the spot for save my life above mention culprits attacked my mother and assaulted her. That due to the said assaults I and my mother sustain injuries the local people gathered there and took my mother and me to the Siliguri District hospital the doctor of said hospital treated me the injuries and admitted my mother to the said hospital they also threatened me with dire consequences and attempted to cause serious harm. I was rescued only after local people intervened. Sir I am a serious heart patient and under treatment.

Sir, I am extremely frightened due to this incident and apprehend further danger to my life and property. I therefore request you to kindly look in to the matter against the above-mentioned persons under appropriate sections of law and take necessary legal action against them. I also request you to kindly provide protection to me and my family.

I shall be highly obliged for your kind consideration.
