Sir,

In producing herewith arrested accused person namely Momina Khatoon (32 yrs/F) W/O Md Kalam of Tikiapara Matangini-1, Ward No.28, PS- Siliguri. Dist- Darjeeling along with seized articles vize i) 18 (eighteen) sealed Plastik Bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each , Amounting of Rs 170/- x 18 =RS. 3060/-) marked as Exhibits-A , ii) 02 (two) sealed Plastik Bottle of Himalayan Gold 60 up country spirit each containing 600 ml, Amounting of Rs 170/- in which was taken out from mother packet box as sample for examination, marked as Exhibits-A1, as per seizure list.

I, ASI Minhaj Al Kader of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Momina Khatoon (32 yrs/F) W/O Md Kalam of Tikiapara Matangini-1, Ward No.28, PS- Siliguri. Dist- Darjeeling to the effect that on 11.01.26 at 09.05 hrs acting on secret source information that the above noted person was busy to sale Id liquor illegally at Tikiapara near Railway Quarter ward No. 28, PS- Siliguri, Dist- Darjeeling in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 521 dated 11.01.26 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Debasish Das, LC/696 Shyafali Barman , C/160 Soumen Sarkar both of Siliguri PS left for Tikiapara near Railway Quarter ward No. 28, PS- Siliguri, Dist- Darjeeling to verify the veracity of the information vide Siliguri PS G.D.E No.522 dated 11.01.26. On reaching at 09.15 hrs at the mentioned P.O and as identified by source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person with the help of lady force and on interrogation, she disclosed her identity as noted above. On being asked she stated that she used to sale the 60 up Country Spirit to her desigh costomer at her locality without any valid documents. On being asked she could not produce any valid documents in respect of the said liquor. On searching i) 18 (eighteen) sealed Plastik Bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each , Amounting of Rs 170/- x 18 =RS. 3060/-) marked as Exhibits-A, ii) 02 (two) sealed Plastik Bottle of Himalayan Gold 60 up country spirit each containing 600 ml,

Amounting of Rs 170/- in which was taken out from mother packet box as sample for examination, marked as Exhibits-A1, and accordingly I seized the same as per seizure list as she has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. She also stated that she is doing this liquor business since long for her wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 09.45 hrs and 10.45 hrs. As such I arrested him U/S-35(1) BNSS after observing all sorts' of rules after mainlining her decency.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Momina Khaton (32 yrs/F) W/O Md Kalam of Tikiapara Matangini-1, Ward No.28, PS- Siliguri. Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
