Sub: COMPLAINT AGAINST SANDIP GUPTA.

Sir,

I, Sri Rabindra Singh son of Sri Samser Singh resident of Samser Villa, Shastri Nagar, Ward No. 41 of Siliguri Municipal Corporation, Siliguri, Police Station- Bhaktinagar, District- Jalpaiguri, would like to draw your kind attention to the fact that on 01.01.2026 my daughter namely Charanjeet Kaur (now deceased) aged about 14 years suddenly started feeling unwell due to cough and cold and was immediately admitted to Mukherjee Nursing Home, Hill Cart Road, Siliguri and after diagnosis the doctor informed that she is/was suffering from pneumonia.

On 03.01.2026 Dr. Revika and Dr. Mainak Mukherjee informed us to take the patient to Desun Hospital as Mukherjee Hospital does not have necessary machinery/equipment required for proper treatment of my daughter and to this I decided to take my daughter to Chennai for proper treatment and immediately my younger brother Sri Ranjit Singh called our insurance agent Sri Sandip Gupta to help us with insurance claim for arranging Air Ambulance to which the said Sri Sandip Gupta informed us that it will take few days for processing the claim to arrange Air Ambulance from the insurance cover/policy.

Later on, the said Sri Sandip Gupta assured us to arrange for Air Ambulance and asked for Rs. 18,50,000/- (Rupees Eighteen Lakh and Fifty Thousand) only and took Rs. 12,50,000/- (Rupees Twelve Lakh and Fifty Thousand) only in cash from me at around 3.00 P.M on 03.01.2026 and assured my brother to arrange for Air Ambulance and asked me to keep the remaining amount ready.

Later at around 3.30 P.M. the said Sri Sandip Gupta informed that the Air Ambulance has been booked and will take off From Bagdogra at 5.30 P.M. and only one person will be allowed with the patient and no luggage will be allowed and further stated that the price as quoted above are of Air Ambulance only and road ambulance charges shall be additional for which I agreed to.

Immediately I informed the Doctor and requested to do the necessary formality for Air Lifting my daughter and the doctors gave anesthesia and arranged for ventilation support to my daughter.

Later when we were about to discharge my daughter for taking her to Airport we again confirmed from the said Sandip Gupta and he started to avoid our call and informed my brother that the Airport Authority at Siliguri are not responding to the mail sent and when we asked to provide the mail he avoided to provide the mail on various pretext and started to consume time on various pretext and later refused for the Air Ambulance service stating that the permission has been denied by Airport Authority and I came to know that he have not booked any Air Ambulance on the day for my daughter and later on after the advice of the doctors we were forced to shift my daughter to Desun Hospital where my daughter left for heavenly abode due to improper treatment.

The said Sri Sandip Gupta for his material/illegal gain have cheated me for Rs. 12,50,000/- (Rupees Twelve Lakh and Fifty Thousand) only and gave false assurance/made false commitment playing with life of my daughter. The said Sandip Gupta have extorted money from me taking plea of my daughter health and have cheated me and for his conduct my 14 years old daughter lost her life.

So, I request you to kindly take necessary action against the said Sri Sandip Gupta for cheating me and killing my 14 years old daughter.
