I Surendra Prasad Saraf S/O Late Mohanlal Saraf resident of Old Alupatty, near Overbridge, PS- Siliguri, Dist. Darjeeling like to inform you that I am the partner of M/S Surendra Alu company , Shop No P.O.-46, Regulated Market, PS- Pradhan Nagar, Dist. Darjeeling. On the night of 13.01.26 at around 01.00 am unknown miscreants entered into my shop and stolen cash Rs 33,000/- (thirty three thousand only) and 11 numbers of silver coin worth Rs 20,000/- (twenty thousand). Later I came to know that the said unknown miscreants also stolen 700/- (seven hundred) from another shop having shop number PO-46A. (Owner name Anirudh Ray- Mobile No 9593333733).

Hence, I pray before you that strong legal action may kindly be taken against the unknown miscreants and please to recover the stolen articles at earliest.
