Dear Sir,

I, Krishna Kumar Sah, Son of Ramweshwar Sah, resident of Baghajatin Colony, P.S. Pradhan Nagar, Dist. Darjeeling would like to inform you that I am the registered owner of one motor vehicle bearing WB 73 E 0586. I entrusted my said vehicle to my own brother, namely ( Santosh Kumar Sah), only for the purpose of driving the vehicle on monthly payment basis. An authorization was also issued in his favour solely to enable him to drive the vehicle lawfully. That after 3-4 Months, I Came to know that the accused was using my vehicle for transporting illegal goods, renting out the vehicle to third persons without my consent, and causing severe damage to the vehicle. That despite my repeated objections and requests, the accused deliberately continued such illegal activities and misused my vehicle for unlawful purposes. When I demanded return of my vehicle, he refused to return the same, falsely claimed himself to be the owner of the vehicle, clearly stated that he would not return my vehicle under any circumstances. He also criminally intimidated me by threatening that he would sell my vehicle in Nepal, an on several occasion abused me in filthy language. He also used obscene and abusive language against my wife, causing immense mental harassment and humiliation to my family

So I therefore humbly request you to kindly take necessary steps against him.
