Subject: - F.I.R.

Sir,

With due respect, I am producing herewith one(01) accused person namely Rajen Lohar (20yrs) S/O Lt. Man Bahadur Lohar of Siyok Gudamdura, PS Sukhia, Dist Darjeeling, under arrest under arrest and the following articles under proper seizure list viz :- (i) one paper made cartoon styled as "MAGIC Movements" grain Vodka Containg 12 (twelve) bottles of Magic Movement Grain vodka each bottle containing 750 ml i.e, total 12 x 750 ml = 9000ml. Marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1".

I SI Bandhan Roy of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned two arrested accused persons namely Rajen Lohar (20yrs) S/O Lt. Man Bahadur Lohar of Siyok Gudamdura, PS Sukhia, Dist Darjeeling to the effect that on 13.01.2026 at about 21:15 hrs, I received specific secret information that one person carrying and possessing a huge quantity of illicit liquor was standing opposite the SJDA Building, Siliguri Junction, under P.S. Pradhan Nagar, and was waiting for a bus to transport the same to Bihar for wrongful gain.

The said information was duly entered in the General Diary of Pradhan Nagar P.S. vide GDE No. 766 dated 13.01.2026, and the matter was intimated to you. As per your kind order and direction, I along with SI Goutam Mallik, ASI Biplab Kumar Das, ASI Prabal Sarkar, and other force personnel proceeded to the spot by government vehicle with investigation kit to verify the veracity of the information.

At about 21:50 hours, we reached in front of SJDA Building, Siliguri Junction. On being pointed out by the source, we noticed one person standing with a carton box. The said person was detained, and our identities as police personnel were disclosed to him. Upon interrogation, he disclosed his identity as Rajen Lohar, as mentioned above.

On search, one paper-made carton containing **12 (twelve) bottles of "Magic Movement Grain Vodka"**, each bottle measuring 750 ml, totaling 9000 ml, was recovered from his possession. One bottle was taken as sample for examination, marked as **Exhibit "A1"**, and the remaining articles were marked as **Exhibit "A"**. The accused failed to produce any valid licence or documents in respect of the recovered liquor. Accordingly, the recovered liquor was seized under proper seizure list in presence of independent witnesses with videography, as per the norms of BNSS. The entire process of search, seizure, and labelling was conducted under videographic coverage between 21:55 hours and 22:05 hours at the spot.

During interrogation, the accused admitted that he was transporting the illicit liquor to Bihar for selling the same at a higher price without any valid licence or permission and that he had been engaged in such illegal activities for a long time for his wrongful gain. Accordingly I arrested the accused person following all legal formalities, informed of the grounds of arrest both verbally and in writing, and brought to Pradhan Nagar Police Station for further legal action.

Hence the accused person namely Rajen Lohar (20yrs) S/O Lt. Man Bahadur Lohar of Siyok Gudamdura, PS Sukhia, Dist Darjeeling has violated the norms of Bengal Excise Act. Therefore, I pray before your good self that a specific case may kindly be initiated against the arrested accused person namely Rajen Lohar (20yrs) S/O Lt. Man Bahadur Lohar of Siyok Gudamdura, PS Sukhia, Dist Darjeeling, under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
