In producing herewith the following seized articles as per proper seizure list:

1. Total 227 (two hundred twenty seven) bottles of Old Monk Delux XXX Rum , each bottle containing 750 ml, total 170250 ml. / 170.25 Ltrs – marked as 'Exhibit-A'
2. Total 72 (Seventy Two) bottles of Haywards 5000 Super Strong Beer, each bottle containing 500 ml, total- 36000 ml. / 36 Ltrs – marked as 'Exhibit-B'
3. 04 (four) sack of potato
4. 03 (three) sack of Ginger
5. One TATA ACE vehicle having Registration No. WB 73 G 6988.

(Article noted in Sl. No. 1 & 2 kept concealed under Sl. No. 3 & 4 and found inside Sl. No. 05)

I, ASI Dilip Sarkar of Khalpara TOP under Siliguri Police Station do here by lodged a written complaint against the driver and the owner of the TATA ACE vehicle having Registration No. WB 73 G 6988 to the effect that today on 13.01.2026 at 00.45 hrs. I received a credible source information that one TATA ACE vehicle having Registration No. WB 73 G 6988 was standing at Burdwan road opposite to Spencer plaza with huge quantity of illicit liquor to deliver the same to their designed customer for their wrongful gain without any documents/license. Subsequently, I informed the matter to the Inspector-in-Charge, Siliguri Police Station and being directed, myself along with SI Newton Biswas, SI Chiranjit Saha, ASI Injamamul Hoque, CV- 980 Ranjan Ojha all of Khalpara TOP-II under Siliguri PS, SPC and along with k-27 Van officer ASI Muzaffar Rahaman Mondal along with C-1486 Pradip Ghosh, C- 1565 Santu Barman left for Burdwan Road opposite to Spencer Plaza under Siliguri PS by Govt. aided vehicle to verify the veracity of the source information. This refers to Siliguri PS GDE No. 443 Dated-13.01.2026 and M.C.C No- 43/2026 Date-13.01.2026.

Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender.

On the way to Burdwan Road, Opposite to Spencer Plaza under Siliguri Police Station , I contacted two persons namely (1) Bapi Roy (32) S/O Bikash Roy of Tumbajote, P.S-Matigara, Dist.- Darjeeling and (2) Md. Muktar Alam (36) S/O Md. Majiruddin of Jyotinagar Colony, Ward No. 04 of SMC, P.S- Siliguri, Dist.- Darjeeling and make them aware about the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with the independent witnesses reached at Burdwan Road opposite to Spencer Plaza under Siliguri Police Station at 01.25 hrs. and being pointed by the source and on being identified by the source our police party approaching towards the said vehicle. But seeing the police party approaching towards them the driver and one associates managed to fled away from the spot leaving the said vehicle.

Thereafter, I searched the said vehicle i.e TATA ACE vehicle having Registration No. WB 73 G 6988 in presence of available witnesses and recovered the above noted articles i.e (1) Total 227 (two hundred twenty seven) bottles of Old Monk Delux XXX Rum , each bottle containing 750 ml, total 170250 ml. / 170.25 Ltrs.- marked as 'Exhibit- A' (2) Total 72 (Seventy Two) bottles of Haywards 5000 Super Strong Beer each bottle containing 500 ml, total- 36000 ml. / 36 Ltrs - marked as 'Exhibit-B' (3) Total 04 (four) sack of potato , (04) Total 03 (three) sack of Ginger


(Article noted in Sl. No. 1 & 2 was kept concealed under Sl. No. 3 & 4 and found inside Sl. No. 05)

Accordingly, I seized the above noted articles in presence of available witnesses. The whole process of seizure and label was made in between 01.45 hrs. to 02.35 hrs. on 13.01.2026. The process of Search & seizure is under videography.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the driver and owner of the vehicle i.e TATA ACE vehicle having Registration No. WB 73 G 6988 and arrange for its investigation.
