I respectfully state that my name is Sanjeev Jaiswal. S/O. Biswanath Prasad Jaiswal, resident at Hill Cant Road, Venus more ward No-06.

I wish to inform you that on 8th Jan 2026 at about timing 3:00 pm. at our flat Agomari Residence, at Dangi Para, Hill Cant Road ward No-06.

My wife, attacked me with the Intention to Grievous assault that could have taken my life, she repeatedly hit me, due to which I suffered Serious Injuries. I received a severe injury on my head, and one of my teeth was broken. I was in fear for my life during this incident. The attack was sudden and intentional, and due to the injuries I required medical treatment. This act amounts to an attempt to murder.

Due to this incident, I have suffered injury, mental harassment & financial loss.
