Respected Sir/ Madam,

I, Smt. Reena Roy, D/o. Lt. Jagesh Chandra Roy, R/o. Bidya Colony, Sevoke Road, Jalpaiguri, Currently Residing at Gurung Busty, Near Gym Town Fitness, W/no. 02, P.S. Pradhannagar, Dist- Darjeeling, would like to state that today at about 10:30 am when I was preparing for taking bath as I was getting late for my daily work at that time 4 persons came in front of my house in the current address mentioned above, along with hockey stick and sharp tools, namely 1. Sumanta kanti Barua, 2. Samar Kanti Barua, 3. Bhabna Barua and 4. Bobby Barua along with hockey sticks and sharp tools and started shouting at me and abusing me in filthy language and started to threatened me that if I don't come outside from my house then they will kill me. when they noticed that I was not responding they rushed into main gate of my house and broke main gate and entered into my house in a aggressive way and two male person mentioned above firstly grabbed me and pulled my hair and dragged into the floor and they all started to assault me mercilessly and the aforesaid persons namely bhabna Barua and bobby Barua kicked me so hardly in my abdomen and lower body parts so that my internal organs may stopped functioning.

That when I tried to oppose them they all assaulted me with the hockey stick and with sharp tools and thereafter I have sustain grievous injury in my head and when I started bleeding even during that time they continuously used their criminal force and the above named male persons with their intention tried to outrage my modesty by disrobing me as well as touching my private body parts and when I opposed and started shouting for help at that time they tried to put clothes inside my mouth so that I cannot breathe and tried to kill me and in that moment they snatched my gold chain which I was wearing. Thereafter listening the hue and cry local people came running seeing such the above noted persons started to break all my household articles as well as threw at me and started to threatened me with dire consequences if I lodge any complaint before any authority they will kill me and then left my house.

That the local people came and saved me and took me to the NBMC and hospital and I was treated there as I was bleeding heavily and got stitched in my head. Now the above named persons are continuously threatening me with dire consequences.

Therefore finding no other alternative way I have come before you to lodge this written complaint against 1. Sumanta kanti Barua, 2. Samar Kanti Barua, 3. Bhabna Barua (Ph. No. 7908295871) and 4. Bobby Barua and take necessary legal action as soon as possible for the ends of justice.
