Sub: - Letter of Complaint against Kartick Adhikary (68) S/O Lt. Ramani Adhikary of Boro Mohan Singh jote PO- Kadamtala PS- Matigara Dist- Darjeeling for illegal Storing and refilling of Domestic Gas Cylinder in his house.

Sir,

In producing herewith the following seized articles with original seizure list, viz:-

- (i) 03(Three) Number of Indane Domestic Gas cylinder which fully empty.
- (ii) 03(Three) Number of HP Domestic Gas cylinder in which one pcs of fully loaded (29.8 kg) and two pcs of empty Cylinder (14.02kg).
- (iii) 20(Twenty) Number of Non Brand company empty small gas cylinders in different colour in which (05) five numbers of cylinders partially loaded.
- (iv) Total 16 (sixteen) pcs of metal nozzle which used for refilling purpose.
- (v) 01 (one) Iron made Range which used for refilling purpose.

I SI Raju Sarkar of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge the written complaint against accused person namely Kartick Adhikary (68) S/O Lt. Ramani Adhikary of Boro Mohan Singh jote PO- Kadamtala PS- Matigara Dist- Darjeeling to the effect that on 14/01/2026 at about 12:35 hrs received a secrete source information that one Kartick Adhikary (68) S/O Lt. Ramani Adhikary of Boro Mohan Singh jote PO- Kadamtala PS- Matigara Dist- Darjeeling is illegally storing, refilling and selling Domestic LPG cylinders i.e. Indane, Hindusthan Petroleum and non branded small gas cylinders at his house located at Boro Mohan Singh jote PO- Kadamtala PS- Matigara Dist- Darjeeling for the purpose of refilling and selling in open market without any valid license or documents for his wrongful gain. Hence I diarized the matter vide EB, SPC GDE No. 79 Dt. 14.01.26 and informed the matter to ACP EB, SPC and as per his instruction myself along with Inspector Debabarata Sengupta, ASI Arghya Das, ASI Pranab Kumar Majumdar L/C 1298 Naisi Parveen, CV 019 Debandra nath Roy all of EB, SPC left EB Office to proceed Boro Mohan Singh jote PO- Kadamtala PS- Matigara Dist- Darjeeling to execute the information. This refers EB, SPC GDE No.80 Dt. 14.01.26 and C.C. No. 03/26 Dt. 14.01.26.

At about 13:10 hrs we reached at Boro Mohan Singh jote PO- Kadamtala PS- Matigara Dist- Darjeeling and contacted with source and being shown and identified by him, I along with officers and force conducted raid in the house of Kartick Adhikary (68) S/O Lt. Ramani Adhikary of Boro Mohan Singh jote PO- Kadamtala PS- Matigara Dist- Darjeeling, the above noted seized articles have been recovered from his House. On being asked the above noted accused person failed to produce any valid documents in support of above noted seized articles.

It is crystal clear that the said person namely Kartick Adhikary (68) S/O Lt. Ramani Adhikary of Boro Mohan Singh jote PO- Kadamtala PS- Matigara Dist- Darjeeling is storing, refilling and selling the Domestic cylinders in his house for his wrongful gain. As per local enquiry it came to light that the above noted person refills gas in violation of safety requirements thus conducted negligently with respect to fire or combustible matter, which may endanger human life or likely to cause hurt or injury to person at that Locality area. Kartick Adhikary does not have any valid License/ Permit of dealing /distribution /refilling LPG. Thus the above noted accused person violated the provision of West Bengal Cooking Gas (License and Control) order 1985 and other Government Orders.

Accordingly I seized the above noted seized articles as per seizure list in presence of witnesses namely 1) Lipi Sarkar W/O Sujan Mali Vill- Thakurpura PS- Balurghat Dist- Dakshin Dinajpur. Tenant of Kartick Adhikary 2) Koushik Mandal S/O Ram Mandal of Govt Colony PS- Matigara Dist-Darjeeling. The seizure was made in between 13:30 hrs to 13:55 hrs.

Hence, I pray that a specific case may be recorded against the accused persons namely Kartick Adhikary (68) S/O Lt. Ramani Adhikary of Boro Mohan Singh jote PO- Kadamtala PS- Matigara Dist- Darjeeling. U/S 287/3(5) BNS R/W Sec 7(1)(a)(b)(c) of EC Act 1955 and other appropriate sections of law.
