Sub: Complaint for registering FIR regarding assault, attempt to murder, robbery and allied offences.

Sir,

I, **Roshan Roy**, son of Chandra Dev Roy, resident of **Sekhar Bazar, Azad Road, Kamala Nagar, Salugara, Ward No. 42, P.O. Sevok Road, P.S. Bhaktinagar, District Jalpaiguri**, respectfully state as follows.

That on **11/01/2026**, at about **9:30 PM to 10:00 PM**, after completing my duty, I was returning to my house. When I reached near the **river side area of Kamala Nagar**, which generally remains dark and isolated, I noticed around **8-10 persons** standing there who were heavily drunk and creating nuisance. As soon as I crossed them, they suddenly started throwing stones at me, due to which I sustained injuries. Thereafter, when I went near them and asked why they were assaulting me, all of them suddenly attacked me together.

That the said persons assaulted me severely with **deadly weapons like kukhri, knife, sickle, iron rod and other sharp and blunt weapons**, aiming at vital parts of my body. The assault was so brutal that it clearly appeared that they intended to kill me. I tried to save myself and requested them not to beat me, stating that I am a local resident and my house is nearby, but they did not listen and continued to assault me mercilessly. Due to the intervention of local people who rushed to the spot on hearing the commotion, I somehow managed to save my life, otherwise I would have been killed. After seeing people gathering there, all the accused persons fled away from the spot taking advantage of darkness.

That during the course of the assault, the accused persons also **robbed me of cash amounting to about Rs. 5,000-6,000, one gold chain weighing about 12 grams, one silver chain weighing about 100 grams, and two gold rings weighing about 5 grams and 8 grams respectively**.

That after the incident, when my family members came to know about the assault, my **wife rushed to the spot** to save me. At that time, the accused persons also **pushed and assaulted my wife**, due to which she fell down and sustained **injury on her head**.

That due to darkness and my injured condition, I could identify only **two persons**, namely **Umesh Adhikari, son of Bashu Adhikari, resident of**

Vivekananda Nagar, Salugara, Siliguri, Ward No. 42, P.S. Bhaktinagar, District Jalpaiguri, and Bablu Roy, son of Bappi Roy, resident of Kamala Nagar, Salugara, Siliguri, Ward No. 42, P.S. Bhaktinagar, District Jalpaiguri. I could not identify the other persons at that time, but they may be identified during investigation.

That the above acts of the accused persons constitute serious cognizable offences including **attempt to murder, rioting, unlawful assembly with deadly weapons, voluntarily causing grievous hurt, robbery with violence, wrongful restraint and criminal intimidation**, punishable under Sections **147, 148, 149, 307, 323, 324, 325, 326, 341, 394, 397, 506 and 34 of the Indian Penal Code**, or any other sections as may be found applicable during investigation.

I am submitting a copy of my **Aadhaar Card** for identification purposes.

I therefore request you to kindly **register my complaint as an FIR**, take necessary legal action against the accused persons, arrest them at the earliest, recover the robbed articles and ensure justice to me and my family.

I shall cooperate with the investigation as and when required.
