Respected Sir ,

I, Raju Saha, S/O – Late R.N Saha, resident of second mile sevoke road, jyotinagar, I.T.I road, near bottle company, Wrad no :- 41, P.S – Bhaktinagar, P.O – sevoke road, Dist – Jalpaiguri, do hereby lodge this written complaint that I am the owner of land measuring 6 kathas in my locality by way of two separate deeds of sale from the previous owners who are also my neighbours at the same locality. I have purchased the said land in the year of 2023 from NishikantaKarmakar, Sampa Roy and others. I am in possession of the said land having all legal documents regarding the ownership of the land and enjoying it peacefully. Recently I have constructed permanent boundary wall around the said land of mine.

Unfortunately one namely Anuram Roy, his wife Sampa Roy who claim themselves as the owner of the adjacent land measuring ½ katha (half katha) which was gifted to them by the same person from whom I have purchased my land. At various instances, those said persons pressurized me to sell out my land to them which I have refused numerous times. Today on 14.01.2026, at morning I noticed that the boundary wall adjacent to their portion of land was demolished and also the gate of my godown which I had constructed on my land for storing cement and rods was vandalized and total 110 bags of cement amounting approx Rs.50,000/- were stolen from the said godown. Thereafter I have informed the police but in the mean time, the said Anuram Roy along with his wife Sampa Roy and few other anti-socials arrived and they tried to enter my land with intention to forcefully take possession of my land. When I resisted, they became furious and violently started to assault me. As a result of which, I felt on the ground, then the said Sampa Roy and others shouted and told Anuram Roy "PRAN E MERE FELO". Then the said Anuram Roy had hit me with heavy wooden block on my head with an intention to kill me. Then one of the associate namely Shankar Roy took one huge stone and tried to assault me on my head with it but it had hit me on my pelvis. Thereafter I got several injuries on my vital organs and later was rescued by my family, friends and neighbours who somehow took me to the Siliguri district hospital.

Therefore I kindly request you to take necessary action against the said offenders in accordance with law and further protect me, my family and my rightful property from the hands of the said offenders.
