Sir

In producing herewith following three arrested accused persons, namely (1) Anil Roy-18yrs s/o Rajit Roy of Vivekanandanagar, ward no-42 PS Bhaktiagar, Dist Jalpaiguri (2) Kanai Das @ Deb Das -25yrs s/o Monoranjan Das of Dasarathpally ward No-44 PS Bhaktinagar Dist Jalpaiguri and (3) Tinku Sarkar- 28yrs s/o Gopal Sarkar of Dasarathpally Bazar, ward No-44 PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:

- 1) One iron made Hammer with plastic butt having length approx. 11 inches recovered from the exclusive and Conscious possession of Anil Roy.
- 2) One iron made screwdriver with plastic butt having length approx 11 inches recovered from the exclusive and Conscious possession of Tinku Sarkar.
- 3) One iron made plus with plastic cover butt having length approx. 08 inches recovered from the exclusive and Conscious possession of Kanai Das.

I, ASI Khagen Barman s/o Lt Noni Barman of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted persons and 8/9 others to the effect that on 15.01.2026 at 00:10 hrs received a specific source information that 11/12 miscreants have assembled at Bhanunagar road, near Ava Diagnostic center under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhaktinagar PS and diarized the fact in General diary vide Bhaktinagar PS GDE No - 684/26 dated 15.01.26 and as per order I along with SI Srimanta Chatterjee, SI Youel Lepcha, ASI Dhurbo Misra, C/374 Debraj Biswas, and C/1431 Dilip Barman all of Bhaktinagar, PS, SPC, left for Bhanunagar road, near Ava Diagnostic center under Bhaktinagar PS to work out the information in hand. This refers to Bhaktinagar PS GDE No- 685/26 dated 15.01.26.

At about 00.25 hrs we arrived at Bhanunagar road, near Ava Diagnostic center under Bhaktinagar PS as indicated by the source we noticed that 11/12 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 03(three) of them with deadly weapons in their possession but rest managed to fled away from the spot taking the advantage of darkness and open place.

On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession. On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 15.01.26 in between 00.40 hrs to 01.05hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 03 (three) arrested accused persons namely (1) Anil Roy-18yrs s/o Rajit Roy of Vivekanandanagar, ward no-42 PS Bhaktiagar, Dist Jalpaiguri (2) Kanai Das @ Deb Das -25yrs s/o Monoranjan Das of Dasarathpally ward No-44 PS Bhaktinagar Dist Jalpaiguri and (3) Tinku Sarkar-28yrs s/o Gopal Sarkar of Dasarathpally Bazar, ward No-44 PS Bhaktinagar Dist Jalpaiguri and others kindly arrange for its investigation.
