I Smt Chitra Pramanick, W/o Sri Pradip Kumar Das, presently residing at 1<sup>st</sup> Floor, Swastik apartment, Opposite N.B.U Gate No.2, P.S-Matigara, District Darjeeling do hereby inform you that due to differences with my husband I and my minor daughter namely Miss Srija Das started to live separately from my husband since 10.04.2015 and thereafter I started to live at Siliguri with my daughter. I shifted to Siliguri as I wanted better education for my daughter and I admitted her at Alphonsus school and I started working as a beautician in a beauty parlour.

Thereafter my childhood friend Sri Pulak Mandal who was my schoolmate used to communicate with me regularly and we used to speak over phone, subsequently he used to come and meet me at Siliguri, gradually he gained my trust and started taking advantage of the same, he told me that he will marry me so I should apply for contested divorce against my husband and he took me to Buniadpur Court and introduced me to a lawyer and accordingly I filed a divorce petition against my husband at Buniadpur Court, Pulak Mandal further told me that he will also apply for divorce against his wife and some days later Pulak will marry me.

He had no problems with his wife neither did he apply for divorce against his wife, he was only using me physically and mentally.

He on 5<sup>th</sup> October 2025 took about 350 gms of gold jewellery from me which were my stridhan property with a plea that he will take a loan by mortgaging the gold jewellery and start a money marketing business, namely "Swapnanir" and he said that he will return them to me after 3 months after releasing them, but after that he started avoiding me.

Under this guise of deceitful marriage Pulak used to have sexual intercourse with me on the false pretext of marriage.

He was supposed to return my jewellery within 01<sup>st</sup> January 2026 but since 01<sup>st</sup> January he has been delaying to return the gold jewellery weighting 350 gm.

Today on 14.01.2026 at about 07:55 p.m I called him over phone but he rejected my call proving he has cheated me.

Under this guise of deceitful marriage Pulak used to have sexual intercourse with me.

I therefore request your good office to look into the matter and do the needful in order to book the miscreants as per the law of the land for having sexual intercourse with me on the false pretext of marriage and thereafter not marrying me, robbing me of my 350 gm gold jewellery and for cheating me.

Please treat this as very urgent and act accordingly.
