With due respect, I am producing herewith the 03 (Three) arrested accused persons namely (i) Md. Tamanna @ Gullu (32 yrs approx), S/O- Lt. Md. Majibul Haque of Sukantapally Near Gas Godown, PO- Matigara ,PS- Matigara,Dist- Darjeeling, (ii) Chotu Jha (30 yrs approx), S/O- Lt. Sankar Jha of Matigara Bhangapool, PO- Matigara,PS- Matigara,Dist- Darjeeling (iii) Rahul Sahani @ Kalu (22 yrs approx), S/O- Gariban Sahani of New Pokajote, PO- Pradhannagar , PS- Pradhannagar, Dist- Darjeeling.

And the following articles under seizure :-

1. One Hacksaw from the possession of accused named **Md. Tamanna @ Gullu**.
2. One Torch light & one Pluse from the possession of accused person named **Chotu Jha**.
3. One iron made Sabol measuring approx 1(one) feet from the possession of accused person named **Rahul Sahani @ Kalu**.

I, ASI Chandra Prakash Adhikari of Matigara PS, Siliguri Police Commissionerate beg to state that on 15.01.2026 at 23.10 hrs, received a secret source information that a gang of miscreants were assembled at Railway underpass near Matigara T.E under Matigara Police Station, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Shibmandir Bazaar area. Accordingly, I informed the fact to I/C, Matigara PS and as per his kind order myself along with ASI Bikash Roy, C/868 Sujal Roy, C/523 Sanjit Kundu, C/ 219 Sanatan Chitrakar all are of Matigara PS, Siliguri Police Commissionerate left for Railway underpass near Matigara T.E, PS- Matigara, Dist- Darjeeling to work out the information in hand vide Matigara PS GDE No. 877 Dated- 15.01.2026. At about 23:20 hrs we arrived at Railway underpass near Matigara T.E under Matigara Police Station. After arrival of the spot and as identified by the source we found that 10/12 persons were assembled Railway underpass near Matigara T.E and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away through the tea garden but we managed to apprehended 03 (three) persons of them. On interrogation, the apprehended accused persons disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there for making preparation for committing dacoity in Shibmandir Bazar area. They also stated that others 07/09 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles from their possessions. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 03 (three) accused persons under proper memo of
