divisions. They were always fighting with me and my sister and abusing
in filthy language.

Today Di.e. 13/01/26 at about 13:15 hrs Rohul Das started
quarrelling with me and after that her wife also giving slang to me,
when I protest myself then both of them physically assaulted me and
my nephew namely (Ayesha Das, F/8 yrs) and they tried to kill us
with bricks. After few minutes my elder brother viray das came
at home and he also started beating me badly. They pushed me on the
way in wrong intentions and ^{to} outraged my modesty. Due to this me
and my nephew get sustained serious injury and any how I managed
my self to fled away from the spot. with the help of my relative
I went to siliguri district hospital for our treatment.
