Respected Sir,

I Faij Ahmed, Son of Farid Ahmed, Advocate of Siliguri Court, having my office/chamber at Below Hotel Vinayak, L.M. Moulick Complex, Hill Cart Road, P.S. Siliguri, Dist: Darjeeling beg to state as follows:

1. That today at around 11:00 am I received a call from one of my neighbor whose shop is above my chamber and informed me that the AC Copper pipe of my chamber has been taken away by somebody.

2. That when I reached my chamber at round 11:15 a.m. from Siliguri Court I when through the CCTV footage which is installed outside my chamber which clearly shows that two unknown miscreants broke the Copper Pipe installed with the outer unit of the AC connected to the indoor unit. The Copper pipe which was visible from the outside of the chamber was completely taken away by them at around 6:15 am to 7:30 a.m. the entire incident took place and

Copper Pipe measuring around 40 to 45 feet long was stolen along with the wires.

3. That just few days back in the same building the Copper Pipe along with the outer unit was stolen. The entire incident has been recorded in the CCTV footage.

I therefore request to kindly take strict action against the aforesaid.
