I Saurav Roy, the above noted complainant beg to inform you that on 11.01.2026 at about 10:00 p.m., the above noted alleged persons of my locality reached at Adarsha Nagar Colony, Near my home, while returning from picknic, in intoxicated condition and they all started abusing me in filthy language and told me to remove my scooter (Antique) bearing Regd. No WB-74-BU-6128 (Regd. owner - Niraj Mahata (22) s/o Sri Narasingh Mahata, of Durga Nagar Colony, Ward No. 4, P.S.-Siliguri) in front of my house and seeing their bad attitude, I told them that I am removing, the said scooter of my friend, Niraj Mahata, noted above, but they suddenly started beating me with fist & blows & damaged the said scooter, and when my mother namely, Swarna Roy (47) wife of Sri Dulal Roy came out of my house and tried to save me then they all were bearing steel/iron Bangles (Bala), attacked on my mother and my said mother received severe head injury, and they all left the place after threatening us for dire consequences and they started abusing the all the people of locality and broken the house gates of my neighbours namely 01 Hasin Khatun (21) s/o Md. Saddam (2) Barsha Roy wife of Gobinda Roy (01) s/o Surali Mahata (19) & Aditya Roy and others and damaged their household goods. Me and my said mother received severe injury on our person, I & my said mother treatment & my said mother admitted to Siliguri Distt. Hospital in at 11.01.26 & discharged on 12.01.2026, but when head part did not decrease & she started vomiting. She was immediately shifted to North Bengal Medical College and presently admitted there. They have come again & tried to quarrel with us. So please take necessary action against them.
