

Sub: Complaint for registration of an F.I.R. against Sri Sourav Banerjee and Sri Sougata Banerjee for physical assault and insult the modesty of women Govt. Official.

Sir,

I, Sri Chinmoy Sengupta, a Govt. employee, presently posted at Non Timber Forest Produce Division, situated at Hakimpara, Ashutosh Mukherjee Road, Near Children Park, P.O. Siliguri, P.S. Siliguri, District Darjeeling, under Directorate of Forests, Govt. of West Bengal, do hereby lodge this complaint against **Sri Sourav Banerjee and Sri Sougata Banerjee**, inhabitant of Hakimpara, Ashutosh Mukherjee Road, Near Children Park, P.O. Siliguri, District Darjeeling to the following effects:

1. That on 16/01/2026 at about 3 PM, I along with Md. Nazrul Islam (also staff) in discharging our official duty wearing departmental uniforms, carrying some official N.T.F.P articles parked our motor cycle on road side footpath near our Division Office, at that time **Sri Sourav Banerjee and Sri Sougata Banerjee**, accompanied by some local miscreants/hooligans who have no regards towards law of land, started using filthy language and without any reason whatsoever, both of them started physical assault and sustained grievous hurt, we were on departmental uniform, this goes to show they have no regard toward law, they did not hesitate to physically assault the Govt. staff who were on uniforms.
2. In that very time our Head Clerk, Subrata Paul reached there to safe/rescue us, then both of them accompanied some local hooligans violently physically assaulted our Head Clerk by fist and blow who sustained severe injuries and had to take medical treatment at Siliguri District Hospital.
3. Then our Divisional Forest Officer, Smt. Manjula Tirkey, WBFS also came down to the event to resolve the dispute but they did not pay any heed and respect to our lady Officer and used obscene and derogatory language thereby insulted the modestly of our lady officer.
4. Then all our staff especially ladies came down from the office to rescue us but they did not spare our ladies staff, they also insulted their modesty by using obscene and filthy language and they also physically manhandled our ladies' staff they received severe injuries and had to take medical treatment at Siliguri District Hospital.
5. That they (**Sri Sourav Banerjee and Sri Sougata Banerjee**) threatened all our staff to face dire consequences in future as they are local and have muscle power. They threatened us to inflict physically. We the staff of Non Timber Forest Produce Division especially ladies are in fear and apprehending danger to life and limb.
6. That they outrage the modesty of lady forest officials, physically manhandled women staff namely Piyasi Barman Biswas and Sunita Das, violently abused women staff thereby sustained severe injuries and had to rush Siliguri District Hospital for their treatment, Medical prescription attached herewith to substantiate the injuries.
