Subject: FIR against murderous attack on my elder brother and the residents of Kholaibakhtari.

Respected Sir,

I, Lal Babu Sah, resident of Kholaibakhtari, Tulsi Nagar, Matigara, Siliguri, District Darjeeling, West Bengal, do hereby lodge this complaint about the incident started on last Tuesday when we gathered to perform weekly Hanuman Chalisa in the premises of Tulsi Nagar Shiva Mandir. One Md Fariyad asked what you all are doing here so we just replied Hanuman Chalisa and left the mandir premises. After sometime OC of PC Party SI Shib Shankar Das called Amit Kumar Gupta about the incident and the video of the mandir was shared with the police But today when we along with few people went to Mandir for renovation of the premises, Md Alaudin disrupted the meeting with some slur words for Puja Mahato. For this incident police was immediately informed and Matigara police arrived and controlled the situation. after police left few ladies namely Sabera Khatoon, Sayeda Khatoon, Chunni Khatoon along with boys Md Salman, Md Sahil of Jyoti Nagar and Md Sahrukh, Md Sultan of Tulsi Nagar and 50 others with rods, baseball stick, bricks, stones incited the mob against Puja Mahato and try to lynch her and started heavy stone pelting in front of her house. In between Manoj Sah, myself, and Rajiv Sah all resident of Kholaibakhtari are badly injured . Manoj Sah is now admitted with hand broken and 4 stitches on head.

Therefore I request you to lodge a complaint and initiate immediate action against the said person for the safety and security of my life and my relatives life and property.
