I ASI Bikash Barman of Matigara P.S. do hereby loge suomotto complaint to the effect that, today on 18/01/2026, I was detailed to perform Mobile Patrol duty from 14:00 hrs vide M.C.C. No. 155/26, Dated 18/01/2026 alongwith force. Before taking up said duty I/C Matigara P.S. briefed me regarding prevailing law and order situation, occurred at Khalaibhaktari Tulsinagar area and he directed me to be present there. Picket duties has already been deployed there to combat any untoward situation. During my said Patrolling duty at about 20:45 hrs I got information from on duty officer Matigara P.S. that again a tension cropped up between two groups at near 'Baro Mastan More', Khalaibhaktari under P.S. Matigara. Accordingly I alongwith force rushed to 'Baro Mastan More' area and found about 150/200 both male and female armed with deadly weapons were assaulting, pelting stone towards police party deployed on duty. Previously deputed police picket parties tried to control the situation but the unruly mob attacked us by stone and deadly weapons. As a result I, ASI Bikash Barman along with ASI Aibul Islam, C/447 Raj Kishore Das, C/306 Wang Dorjee Lama sustained grievous injuries on our persons. After re-enforcement somehow we could arrest the above noted accud persons and seized above noted articles from place of occurrence who were directly involved in assaulting police. After that the situation became under control.

Therefore, I pray before your kind honour that a specific case under proper section of law may kindly be started against (i) Krishna Sah (26) S/O Late Munna Sah of Maharaj
