Subject: Preplanned Assault on Me and Dumping of Hazardous Materials at 146, M. G. Road
(16.01.2026 after 4:15 PM)

Sir,

I, Sachin Mitruka, son of Anil Mitruka resident of 146, M. G. Road, Siliguri, hereby inform you that on 16 January 2026 (yesterday) after 4:15 PM, Bimal Mitruka and his son Keshav Mitruka came to our common/ancestral premises and started dumping chemical drums and poisonous/hazardous materials in plastic containers in the common entry/passage area. When I objected and asked them to remove the hazardous materials, Keshav Mitruka caught and held me tightly, and Bimal Mitruka assaulted and hit me. I sustained severe injury/pain in my right wrist/hand, along with back injury and scratches on my legs. The assault appears preplanned, as they regularly threaten us verbally and are prepared for physical violence to always ensure breach of peace at our premises.

Dispute/matter is pending before Siliguri Municipal Corporation, yet they continue bringing hazardous materials. Earlier they dumped one truck of sand and stocked iron gutters, blocking the entrance/passage. Children aged 8 years, 4 years and 6 months use the passage daily for school, different classes, to come to our office to meet etc, this exposure may endanger life/health of children as well as adults. Around 3 months ago, a snake emerged from the same area; a snake catcher was called so that the snake doesn't get inside the home. About one week ago, our 80-year-old grandmother fell near the entrance due to the stocked gutters, luckily she escaped major injuries. They had earlier destroyed our CCTV camera so that none of their misbehaviours and illegal activities gets captured in recording, and the complaint is already lodged at this outpost.

I therefore request you to take necessary action as per law.
