I, Shri. Sukanta Das, son of Shri. Shibulal das, resident of Nivedita Road by lane, Ward no. 2 SMC, P.O. & P.S. Pradhan Nagar, Dist: Darjeeling, Pin: 734003, would like to beg to state that on 29/12/2025 at about 6 PM in the evening when I was walking in Nivedita Road by lane just opposite Mio Amore cake shop suddenly a car bearing no. WB 74 AP 7000 coming from Champasari rashly and due to such driving I fall down on the road. When I got up and asked the driver of the vehicle why he is driving the car so rashly he started to abuse me with filthy languages and thereafter came down from the car and hit me with fist and blows. Then to protect myself I shouted for help then said driver pushed me on the road and tried to run over me by his car but I somehow rescued myself with the help of the local resident.

That thereafter I came to know that the name of the said driver is Raju Saha, son of Late R.N. Saha, resident of 2nd Mile, Jyotinagar, P.S Bhaktinagar, Dist. Jalpaiguri, was the driver as well as the owner of the said vehicle.

That due to such incident I have suffered injuries and thus pray before you to take necessary action against the said Raju Saha (9800610000). I was unable to file the FIR at the earliest as I was out of station for the medical care of my father.
