Respected Sir,
I Sunaina Prasad, respectfully submit this letter to bring to
your notice the harassment and illegal actions committed
against my brother Mr. Tripurari Prasad, Sister in law
Renu Prasad and Buddi Prasad at my late father's
residence. Also the rabouts are harassing me and threatening
me.

My mother and I had gone to Bangalore after securely locking
my room at my father's residence. When we returned, I was
shocked to see that my brother had forcefully opened my
locked room without my permission and thrown all my
belongings outside the room. Incident happened on 20th Dec 2025.
Further, several of my personal belongings have been stolen
including:

- Jewellery
- Books
- Cloths
- Utensils

Other household and personal items.
When I questioned him regarding this unlawful act he, hit, and
beaten me also to my mother further making it unsafe for me
to enter my own room. His action amounts to criminal trespass,
theft and harassment. Take action against Tripurari, Renu
and Buddi, Help me recover my safe re-entry into my room and
help me recover my stolen belongings. I request your
urgent intervention in this serious matter.
