Dear Sir,

With due respect, I would like to lay following few lines for favour of your kind consideration and necessary action.

On 9/01/2023 I sold my Hyundai car Verna bearing registration number WB74AY0964, to Samar Majumdar, son of Samir Ranjan Majumdar, residing in Rome apartment, fourth floor, flat number:403, 141 RN guha road, gol park, dumdum s.o Kolkata westbengal 700028. The sale was conducted in good faith, and all necessary documents were duly completed at the time of the transaction.

However, despite numerous attempts to follow up and facilitate the transfer of ownership to the buyer's name, I have not received any confirmation or documentation regarding the transfer. It has come to my attention that the vehicle remains registered under my name, which is concerning given the potential liabilities associated with owning a vehicle that is no longer in my possession.

I have made several attempts weekly to contact the buyer to resolve this matter amicably, but unfortunately, all my efforts have been in vain. At this juncture, I believe it is imperative to seek assistance from law enforcement to ensure a prompt resolution to this issue.

That since one week one person namely SK Raju, S/O. Sk Nurul of 6h/13/1 Moulana Md Ali Road, Kolkata-23, Khiddirpore, Circus Avenue, Kolkata-700023 started calling me several times and states that

he has purchased my above mentioned vehicle from Samar Majumdar and told me to take back vehicle be paying Rs. 4,70,000(rupees four lakh seventy thousand) immediately.

That yesterday at about 4-5 pm SK Raju again called my son Krish Agarwal by his mobile no.9804071906 and told him to take back the vehicle at the price he had demanded above. He is not transferring the ownership of the vehicle in his name. As I had requested him to transfer the ownership but he is denying to transfer the vehicle in his name. If any case occurs in the vehicle I shall not be held liable.

Therefore, I request you to kindly accept this F.I.R. and to take necessary legal actions to recover my vehicle and for punishment of the above name culprits at the earliest and oblige.
