Sub: Written Complaint (F.I.R.)

Sir,

With due respect I, **Sri Ram Prasad Bin**, Son of Musabir Bin, of Shib Nagar, Hatiduba, P.S. Pradhan Nagar, Dist - Darjeeling beg to inform you that I along with many others have went on to a picnic at Bange today i.e. on 18/01/2026 I was on a picnic at Bange with a group of friends, an individual named Bikash Rai, son of Naresh Rai, resident of Mallaguri, initiated a heated quarrel with us in a heavily intoxicated state. Later, at approximately 6:00 PM, while we were returning home, our bus was intercepted and forcefully stopped at Mallaguri More by the said Bikash Rai and his brother, Bishal Rai, who were accompanied by a mob of approximately 20 (twenty) unknown associates. All of them were armed with dangerous weapons, including sticks and revolvers.

Under the immediate threat of the firearm, the accused persons entered into the vehicle and launched a merciless and inhuman physical assault upon me and Sukumar Sutradhar, Rajesh Sarkar, Biswajit Sarkar, Chayan Sarkar (Mithu), Arbind Chatiya, Amresh Das, Sushil Chandra Sarkar, Kajal Chowdhury, and Abhishek Dorjee and under the fear of the revolvers we remain silent. During this attack, some person in their group used the butt of the revolvers to strike Chayan Sarkar & Biswajit Sarkar on the head / face with an intention to kill them, causing a severe wound. The group also targeted Biswajit Sarkar, resulting in multiple broken teeth and a critical injury to his left eye due to which he is unable to see from his left eye.

The assault only ceased when local residents began to gather at the scene, causing the attackers to flee. However, before retreating, Bikash Rai and Bishal Rai committed robbery by stealing the soundbox and amplifier from the bus. They also issued death threats, warning us of dire consequences if we dared to report this matter to the authorities.

As a result of this brutal violence I along with Biswajit Sarkar, Chayan Sarkar, Amresh Das, and Sushil Chandra Sarkar sustained serious injuries and were rushed to Siliguri Civil Hospital. Currently, Biswajit Sarkar and Chayan Sarkar remain in critical condition and have been admitted for emergency medical observation. The said Biswajit Sarkar and Chayan Sarkar due to their serious condition they were both referred for CT scan for any internal hamarage in the head or brain.

They are continuously threatening us over phone that they will visit out house and we will face dire consequences; if we inform the same to any authority and tried to take any steps against them. Therefore, you are requested to take proper legal action against the said Bikash Rai, Bishal Rai and his more or less 20 (twenty) antisocial associates.
