Subject: Written complaint against (1) Nityananda Mandal, (2) Krishna Mandal (Brother of Nityananda Mandal) both No. 1 & 2 are residents of Ghoghomali Netajipara, P.O. Ghoghomali, P.S. Bhaktinagar, Dist: Jalpaiguri, in the State of West Bengal and (3) Ranjit Singh, along with their other unknown associates.

Respected Sir,

I, ASHA CHHETRI, D/o. Lt. Satrughan Chhetri, Indian citizen, permanent resident of Sai Marg, Gurung Busty, P.O. & P.S. Pradhan Nagar, Dist: Darjeeling and presently residing at Lane No. 3 of Pabitra Nagar, Champasari, P.O. & P.S. Pradhan Nagar, Dist: Darjeeling, in the State of West Bengal 734003 do hereby submit this written complaint on the basis of the facts stated herein below:


1. That I am the lawful legal heir of Late Ganesh Chhetri @ Late Ganesh Kumar Chhetri, who was the absolute owner of land measuring 33 decimals, situated at Mouza Dhaknikata (83), District Darjeeling located at Panchanai Busty, Opposite Durga Hyundai, Hillcart Road, which falls under the jurisdiction of Pradhan Nagar Police Station.
2. That since the year 2024, I have been in actual, peaceful, continuous and khas possession of the said piece and parcel of land and have been exercising full ownership rights without any obstruction.
3. That I further state that I also hold a valid and subsisting Record of Rights (ROR) in respect of the total land measuring 30 decimals, corresponding to L.R. Khatian No. 2184, R.S. Khatian No. 5/1 and L.R. Plot No. 450, R.S. Plot No. 161, 163, 177 which was duly allotted and recorded in my favour on 19.06.2024.
4. That by virtue of two registered Deed of Gift, being Deed No. 7554/2025 and Deed No. 7555/2025, both registered before the ADSR, Bagdogra on 23.09.2025, I became the absolute owner of land measuring 6 Kathas 8 Chhataks respectively.
5. That at present a Title Suit is pending on the subject matter of the said piece and parcel of plot before the Ld. Civil Judge (Junior Division) at Siliguri being Title Suit No. 04 of 2026 and considering the same the Ld. Court was pleased to pass an order of Injunction on dated 08/01/2026.
6. That all of the alleged persons with an ulterior motive to create further hinderance and disturbance over the suit land have violated the order of the

Ld. Court by violating the Status quo imposed upon the suit land and have painted their names over the said plot boundary made out of Tin Sheets.

It is pertinent to mention here that the Ingress and Egress activities of the alleged persons over suit land is still happening and at present they have installed a pad lock into door of the suit land and all of these activities are going on in my absence to fulfill their illegal activities.

7. That while raising objection over their activities of violation I have been subjected to various verbal threats and verbal abuses keeping themselves in the shade of influential political party & people.
8. That due to the continuous acts, threats and harassment of the alleged persons, I am living under constant fear for my life and personal safety even after obtaining an order of Injunction from the jurisdictional court.

In the light of the statements as stated above, I therefore request your kind authority to kindly take the strongest legal action against those antisocial land mafias who are trying to forcibly grab my land by violating the order of the Ld. Court and also with ulterior motive to harm me. Consider conduct and activities I strongly doubt that they can do anything grab my land.
