Respected Sir,

With due respect SI Chabilal Sinha of New Jalpaiguri Police Station Siliguri Police Commissionerate, Dist. Jalpaiguri beg to lodge a complaint regarding an incident of communal provocation allegedly committed by i) Pinki Mahanto WO- Tapash Mahanto, ii) Anjali Mahanto SO- Bhupati Mahanto, iii) Amit Paswan SO- Bablu Paswan, iv) Paban Adhikary SO-Lalbu Adhikary, v) Biswajit Biswas SO-Sachin Biswas, vi) Sanjib Biswas SO-Sachin Biswas, all of Basbari Ramnagar Colony, PS- NJP, Dist- Jalpaiguri and others from different places, which has the potential to disturb communal harmony and public peace in the locality under your jurisdiction. That on 11/01/2026 around 13.00 Hours the above noted persons along with others deliberately made provocative and inflammatory statements/acts of a communal nature at VIP Road, Madani Bazar, PS- New Jalpaiguri, Dist- Jalpaiguri. Such statements/acts were intended to incite communal feelings among members of different communities and may lead to breach of peace and law and order problems. The aforesaid act amounts to a serious offence as it promotes enmity between different communities and is prejudicial to the maintenance of public tranquillity. The conduct of the said person has caused resentment and fear among the local residents.

I therefore request you to kindly take cognizance of the matter and pray for start a specific case under proper section of law as per law as well as arrange for its investigation.
